Also reminded to catch coughs and sneezes in tissues – Follow Catch it, Bin it, Kill it and to avoid touching face, eyes, nose or mouth with unclean hands. Management checks to ensure this is adhered to.</p>

		<p>Conference calls to be used instead of face to face meetings.          Ensuring sufficient rest breaks for staff.          Social distancing also to be adhered to in canteen area and smoking area.</p> <p><b><u>Wearing of Gloves</u></b>          Where Risk Assessment identifies wearing of gloves as a requirement of the job, an adequate supply of these will be provided. Staff will be instructed on how to remove gloves carefully to reduce contamination and how to dispose of them safely.</p> <p><b><u>RPE</u></b>  <i>Public Health guidance on the use of PPE (personal protective equipment) to protect against COVID-19 relates to health care settings. In all other settings individuals are asked to observe social distancing measures and practice good hand hygiene behaviours</i></p> <p>Where RPE is a requirement for risks associated with the work undertaken the following measures will be followed-          Tight-fitting respirators (such as disposable FFP3 masks and reusable</p>	<p>Staff to be reminded that wearing of gloves is not a substitute for good hand washing.</p> <p>To minimise the risk of transmission of COVID-19 during face-fit testing the following additional measures should be carried out –          Both the fit tester and those being fit tested should wash their hands before and after the test.          Those being fit tested with non-disposable masks should clean the mask themselves before and immediately after the test using a suitable disinfectant cleaning wipe (check with manufacturer to avoid damaging the mask).          Test face pieces that cannot be adequately disinfected (e.g. disposable half masks) should not be used by more than one individual.</p>

Wearers must be clean shaven.</p> <p><b>Symptoms of Covid-19</b>          If anyone becomes unwell with a new continuous cough or a high temperature in the workplace they will be sent home and advised to follow the stay at home guidance. Line managers will maintain regular contact with staff members during this time. ## REMEMBER TO:

**Wash your hands**

Wash your hands with soap and running water when hands are visibly dirty

- when caring for the sick

**Protect others from getting sick**

When coughing and sneezing cover mouth and nose with flexed elbow or tissue



Throw tissue into closed bin immediately after use



Clean hands with alcohol-based hand rub or soap and water after coughing or sneezing and when caring for the sick
